

### **STEP 1** TO BECOME A STUDENT MEMBER

The very first step to becoming a Resonance Repatterning® student is to register as a Student Member of the Resonance Repatterning International Institute and pay the membership fee of \$150.

- 1. The new student should write to admission@resonancerepatterning.com.
- 2. The student will then receive an email with instructions on how to complete the registration process and upload the required information.

## LEVEL 1 GRADUATION FROM STUDENT TO CERTIFIED PRACTITIONER STATUS

### STEPS/CRITERIA TO GRADUATE FROM STUDENT TO CERTIFIED PRACTITIONER

You can complete this status after the end of the Five Element and Meridian programme.

It is important that you check first that you have met/are able to meet the criteria as listed below under requirements and observations before you start this process

### A. HIGH LEVEL OVERVIEW OF PROCESS STEPS TO FOLLOW TO ACHIEVE CERTIFIED PRACTITIONER

- In the event the student is not a member of RRII, they write to <u>licensesupport@resonancerepatterng.com</u> and take out membership at Student level.
- The student writes to <u>licensesupportaresonancerepatterng.com</u> and advises of their intent to become Certified Practitioner and sends verification of the RR courses they have taken or their certificate of attendance.
- The student pays the observation fee and notifies <u>licensesupport@resonancerepatterng.com</u>.
- The student will then upload the requirements listed under "requirements" and "observations required" below into the designated folder supplied by the International Institute.
- The Certification/Quality Assurance team will check the respective documents and videos, provide feedback, and confirm status as Practitioner.
- The student will then **pay for their Certified Practitioner licence and membership** and notify <a href="licensesupport@resonancerepatterng.com">licensesupport@resonancerepatterng.com</a>.
- The student will receive confirmation of their achievement along with the logo to use and certificate of achievement. - 1. Complete the Fundamentals, Primary Patterns, Unconscious Patterns, Chakra Patterns & Five Elements and Meridian Patterns programmes either online or face to face.
- 2. Read all the books cover to cover.
- 3. Complete the skills development assignments in all the books as you go through the programmes.
- 4. Provide a written declaration that you have completed points 2 and 3 above.
- 5. Construct a typed-up Excel spreadsheet called "Session Log" at the start of your Fundamentals programme, which records the following information for every session, even short practice sessions.
  - Date, the full name of the person receiving a session, type of session (i.e., in-class practice or out of class practice with friend/family or self-session), name of the session (i.e. orientation etc.), length of the session (i.e., minutes/hours), reflection: areas that you feel that you could have done better, areas that you feel you did well, and lastly, any aspects of the session that you believe may mirror what is going on inside of you. Add each person's email address and telephone number, as we may call a handful to find out about the experience.
  - Keep this sheet and carry on adding to it during the course of your journey through your Resonance Repatterning training.
  - Save a copy of each of the session notes for all the sessions you have listed.
- 6. Complete **20 full self-sessions** and **20 full in-class** or practice sessions with friends/family/class members and demonstrate the ability to run a session appropriately. (You started with your list in the Fundamentals and Primary Patterns class make sure you add to this).
- 7. Complete all **twenty-six (26)** repatternings on yourself.
- 8. Explain Resonance Repatterning & muscle checking.
- 9. Highlight the sessions on your "Session Log" that fulfil points 6 above.
- 10. Keep the session notes from the sessions recorded in video and obtain written consent from each client to share their session notes for observation purposes and upload these to your online repository.

# C. THIS IS THE OBSERVATION PROCESS FOR REPATTERNINGS TO ATTAIN PRACTITIONER LEVEL AND TO BE UPLOADED ONLINE

NB. Students can be observed conducting repatternings with an energizing option in person or online by a designated observer approved by the International Institute who is part of the Certification Committee.

This can also be undertaken during a repatterning training process or the student can record sessions privately and submit them.

If undertaken in person - the sessions must still be recorded and uploaded.

- 1. Students demonstrate each requirement listed below in D
- 2. These are to be recorded via Zoom or similar technology that can be easily uploaded.
- 3. All videos **must be recorded in gallery view** so both the student and their 'client' are visible and their interaction can be observed.
- 4. All videos must not exceed 1GB in size. Please use an online tool or other software to compress larger videos.
- 5. Send a maximum of two recordings with an Energy Constriction Release included, unless the ECR is completed separately as a 3rd recording.
- 6. The explanation of RR & muscle checking should be included as part of the introduction to a client session.
- 7. Each can be recorded individually, or 2 or 3 can be combined as part of a larger session.
- 8. Ensure every person that you video has signed a waiver for the information to be used for observation purposes and that their data will be protected as much as is possible but cannot be guaranteed see your license to practice agreement and upload a copy to your online repository.
- 9. Ensure you obtain permission to muscle check for your 'client' at the beginning of each recorded session and clearly explain your level of training and that you are in a certification process.
- 10. Upload the points 4-8 above in B above, plus video recordings as described in section D.







### D. AREAS OF DEMONSTRATION

In addition to an Energy Constriction Release and an explanation of Resonance Repatterning, muscle checking (or umbilical muscle checking), coherence, energy and resonance; **two (2)** repatternings must be demonstrated from the list below:

- With at least one that includes an earlier experience
- And with the use of a Diffusion or Fusion as an energizing option
- 1. Parental Repatterning
- 2. Earlier Experience Repatterning
- 3. Sound Frequency Repatterning
- 4. Chakra Repatterning with the Earlier Experience







## LEVEL 2 GRADUATION FROM CERTIFIED PRACTITIONER TO ADVANCED CERTIFIED PRACTITIONER STATUS

### Steps/Criteria to graduate from Certified Practitioner to Advanced Certified Practitioner

You can complete this status after completing the Basic Series, plus the advanced programmes (see B below).

 Before you can complete this Advanced Certified Practitioner status, you <u>must have achieved the</u> Certified Practitioner Status.

NB. Practitioners can be observed conducting repatternings with an energizing option in person or online by a designated observer approved by the International Institute who is part of the Certification Committee.

This can also be undertaken during a repatterning training process or the student can record sessions privately and submit them.

If undertaken in person - the sessions must still be recorded and uploaded.

- 1. Practitioners demonstrate each requirement listed below in D.
- 2. These are to be recorded via Zoom or similar technology that can be easily uploaded.
- All videos must be recorded in gallery view so both the practitioner and their client are visible and their interaction can be observed.
- 4. All videos must not exceed 1GB in size. Please use an online tool or other software to compress larger videos.

#### STEPS/CRITERIA TO GRADUATE TO INSTRUCTOR

The most significant change in Resonance Repatterning® is that you can now apply for this status after completing your Certified *Practitioner level*.

The starting point is to learn how to teach Fundamentals and Primary Patterns combined, which is the now the new RR Fundamentals – Pathway to Change.

It is important that you check first that you have met/are able to meet the criteria as listed below under requirements and observations before you start this process.

### A. HIGH LEVEL OVERVIEW OF PROCESS STEPS TO FOLLOW TO ACHIEVE INSTRUCTOR LEVEL

- A Qualified Teaching Instructor in good standing provides the practitioner with written approval or the

  return with all the associated documentation along with a video that describes why you want to take on the role of Master

### B. THESE ARE THE REQUIREMENTS TO BE COMPLETED AND UPLOADED INTO THE DESIGNATED ONLINE REPOSITORY PROVIDED TO YOU:

- 1. Attain Master Practitioner Certification and Instructor Certification.
- Provide a copy of your verification of courses taken, including Trauma Training.
- 3. Provide proof of payment of the \$350 observation fee.
- 4. Attain accreditation to run all training programmes including training and mentoring teachers
- During a period of 12 months, demonstrate the capability of handling and transforming at least four (4) groups on a programme from basic level with documented progress to Certified Practitioner status.
- Demonstrate documented coaching and mentoring of at least one challenging teacher and turn performance around. 6.
- 7. Continue adding to your "Session Log" spreadsheet that you created at the start of your Fundamentals programme, which records the following information for every session:
- 8. Date, the full name of the person, objectives of the session with student/teacher vs. accomplishments, reflection: areas that you feel that you could have done better, areas that you feel you did well, and lastly, any aspects of the session that you believe may mirror what is going on inside of you. Add each person's email address and telephone number, as we may call a handful to find out about the experience.
  - Keep this sheet and carry on adding to it during the course of your journey through your Resonance Repatterning Career.

### C. THIS IS THE OBSERVATION PROCESS FOR REPATTERNINGS TO ATTAIN MASTER INSTRUCTOR LEVEL AND TO BE UPLOADED ONLINE

If undertaken in person - the sessions must still be recorded and uploaded.

- Teacher demonstrates each requirement listed below in D.
- These are to be recorded via Zoom or similar technology that can be easily uploaded.
- All videos must be recorded in gallery view so both the practitioner and their client are visible, and their interaction can be observed.
- All videos must not exceed 1GB in size. Please use an online tool or other software to compress larger videos. 4.
- Each can be recorded individually, or 2 or 3 can be combined as part of a larger session and clearly marked.
- 8. Ensure every person that you video has signed a waiver for the information to be used for observation purposes and that their data will be protected as much as is possible but cannot be guaranteed - see your license to practice agreement - and upload a copy to your online repository.
- 6. Upload the points 1-7 above in B, plus video recordings as described in section D.

Session 1: Demonstrate a 1.5-hour transformative live spontaneous Resonance Repatterning session of observer's choice during an observation, including coaching
